

INVITATION TO BID

1. The Municipal Government of Calauan, Laguna intends to apply the aggregate amount of **THREE MILLION SEVEN HUNDRED FORTEEN THOUSAND THREE HUNDRED FORTY-SEVEN-SEVEN PESOS AND TEN CENTAVOS (Php 3,714,347.10)** being the Approved Budget for the Contract (ABC) to payment under the contract specified in the succeeding projects. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Municipal Government of Calauan, Laguna now invites bids for the preceding projects of the Municipal Government of Calauan, Laguna. Completion of works is required within the specified above **contract duration** upon the signing of the contract after the issuance of the Notice to Proceed. Bidders should have completed, **within the last two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in section II, instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Interested bidders may obtain further information from the Municipal Government of Calauan, Laguna Bids and Awards Committee for Secretariat and inspect the Bidding Documents at the address given below during the office hour 8:30a.m. to 4:30p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **March 21, 2023 to March 27, 2023 (8:30 am to 4:30 pm)** from the address below and upon payment of a non-refundable fee for Bidding Documents in the amount specified above. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity on **March 21, 2023 to March 27, 2023 (8:30 am to 4:30 pm)**, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the day before the submission of their bids.
6. The Municipal Government of Calauan, Laguna (BAC) will hold a **pre-bid conference on March 28, 2023 at 2:00 pm, @ Municipal Conference Hall, Brgy. Kanluran, Calauan, Laguna** which shall be open only to all interested parties who have purchased the bidding documents.
7. Bids must be duly received by the BAC Secretariat through the address below on or before **April 12, 2023 at 2:00 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the Instruction to Bidders (ITB) Clause. Late Bids shall not be accepted
8. Bid opening shall be on **April 12, 2023 at 2:00 pm, @ Municipal Conference Hall, Brgy. Kanluran, Calauan, Laguna**. Bids will be opened in the presence of the bidder’s representative who choose to attend at the address below.

The Municipal Government of Calauan, Laguna reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 revised Implementing (IRR) of RA 9184, without thereby incurring any liability to the affected bidders.
